Appendix A Annual Report - Chair

Population Geography Research Group Chairs Report

As part of the planned activities for the 2022-2023 year, we sought to have a series of forward facing events that presented themes and discussions for population geographies towards the next 50 years. However, our activities have very much been situated within the context of UK higher education, of which two are of significant relevance: 1) the increased time pressures that UK academics are facing as part of the day job 2) the continued and escalating industrial action in UK higher education. As a result, the events we planned are taking place through existing structures of the RGS-IBG as opposed to stand alone events.

These are notably:

- Sessions as the RGS-IBG conference
- Discussion about the census as part of the AGM.

In addition, to the above we have:

- Continued the blog series on the population geographies website.
- Completed the Archiving Population Geography research project.

In population geography we also have the wider questions of what is population geography, but this question has been secondary this year. Our activities for the year continue to raise questions about the tensions between what is a research group for/who is the research group for/how can we protect the work-life balance of the committee members. The work of the group relies of the input of the committee members and I can only thank the committee this year for all the work they have put in.

I am standing down as Chair and the wider committee this year (a year early) due to an admin role I am taking on in my day job. I've been a committee member for 8 years now, 5 of which have been at the 'executive level' and the support of the committee(s) and the wider population geography community have been a highlight of my academic career. I'm looking forward to seeing what the research group does next.

The current report is for the period between 31 August 2022 and 21 August 2023, covering slightly shorter than one calendar year due to the dates of the 2023 PopGRG AGM.

There are now no outstanding payments that need to be made for the PopGRG activities completed during the last year. PopGRG completed three outstanding payments for the activities completed during the 2021-2022 financial year:

- 1) PopGRG provided a £20 thank you voucher to Pernille Spence, who judged the PopGRG Image Competition in 2022 and selected the winners. Payment for a £20 Amazon gift card to Pernille Spence made on 05 Sep 2022 by the Treasurer Sergei Shubin (who was reimbursed the cost of £20 on the same day).
- 2) Payment was made to Alan Bilton on 16 Sep 2022 for the PopGRG online writing workshop (part of PopGRG retreat) conducted on 4 July 2022.

3) As PopGRG took ownership of the IMigMob conference, it has also agreed to provide

conference bursaries to selected participants. There was a delay with the payment of the bursary

awarded to Julie Fromentin as this involved additional charges for international money transfer

(the recipient only provided a French bank account). In consultation with RGS-IBG (Sarah

Evans) and PopGRG Chair, it was decided that PopGRG would pay the bursary (£100) plus

the fees levied by Lloyds bank for international transfers. The bank fees amounted to £15,

making the total cost of paying the bursary at £115.

At the PopGRG AGM in August 2022 it was decided that in the future PopGRG will request

all bursary/award recipients to provide UK bank accounts for receiving payments. If UK

account cannot be provided, PopGRG would make it clear to the award recipients that it will

only pay the indicated award amount, without covering the extra charges for international bank

transfer (making the final received amount smaller).

As it stands, the Group's income was more than its expenditure (deficit) by £326.20. The

overall end of year balance is £2459.59. The RGS-IBG subvention was the main sources of

income.

We had communication with the former PopGRG Treasurer Nigel Walford, who kindly agreed

to pay of £31.41 for his book royalties to the PopGRG account and attempted to make this

payment by cheque. Unfortunately, this cheque bounced as it was addressed to the old name of

the PopGRG account, which was subsequently changed. It was not possible to process and

redirect this cheque before the current report was completed.

The account remains at the Lloyds Bank, Park Row, Leeds and no bank charges were incurred.

The balance in the account is sufficient to cover anticipated expenditure over the next year.

The sponsored sessions consist of 7 slots across 5 sessions. There appeared to be a lower request for sponsorship this year, which (anecdotally) appears to be a common experience among other research groups. Consequently, we did not fill our full allocation of sponsored sessions. We may consider ways of encouraging more sponsorship applications for 2024.

The Group also adopted the practice of sponsoring one session when sessions sought sponsorship from more than one research groups to provide a broader range of sponsored sessions and to minimise situations where sessions held multiple sponsorships. However, we may wish to revise this approach for 2024 as we did not succeed to allocate our allowance of passes.

The Group also secured 5 guest passes for the following three people:

Jen Gill, actor and LGBTQIA+ activist (1 day)

Esther Mamadou, actor and human rights activist (1 day)

Samuel Sebastian, film-maker (3 days)

All three are participating in the DYSTOPIA film viewing and discussion session sponsored by the group. A final application was anticipated from another person associated with the film but did not materialise.

Again, requests for passes were very low, and we did not succeed in distributing our full allowance. We may also seek ways to promote this opportunity further in 2024.

Please accept my sincere apologies for today's Population Geography Research Group (PopGRG) AGM, which I am unable to attend as I am away from my office.

My term as Memberships Officer has come to an end. Thank you to the team for an enjoyable period of service on the committee, and thanks to Sophie Cranston in particular for her excellent leadership as PopGRG Chair. May I wish my replacement all the very best in their new role. I will, of course, continue to support the PopGRG, including through the International Conference on Population Geographies, which will be hosted by Queen's University Belfast from Monday 1st to Wednesday 3rd July 2024.

The PopGRG has a healthy and relatively steady membership of just under 150 people. There was a very slight decline in membership numbers in the period August 2022 to 2023, reflecting a continued trend of a small loss of members in the last few years. One of the future priorities for the committee might be to consider this small but steady loss. Is this common to other research groups? What are the reasons for leaving the group? I undertook some initial analysis along these lines and found that our group's patterns of retention/loss were not unusual, but this could be updated and explored in more depth.

We are delighted to have welcomed several new members this academic year, including Postgraduate Fellows. We do not currently have a consistent approach to welcoming new members, and this might be something the new Memberships Officer could consider implementing.

In last year's report I noted that we aimed to explore synergies between research groups, building on PopGRG's 50th anniversary celebration event in 2021. The Memberships Officer could have a distinctive role in this exercise, in considering membership of which research groups are most commonly held alongside PopGRG membership, and how best to build on these relationships.
